******SAVE THE DATE...January 14th, 2019******

All owners should have or will be receiving a special meeting packet for internet provider selection. It is imperative that you read the materials provided in the packet and attend this meeting, if possible. It is our hope that we can get a majority vote at this time to decide if bringing in another company is best for the community. The community involvement is needed as there will be a disruption to most, if not all, properties and the Board wants to ensure you are all informed and participating in any decisions to move forward with this project.

Given the time sensitivity, Hargray provided their proposal quickly over the holidays to allow for distribution of something to the community. Now being back from holiday break, the Hargray representative has been able to speak to others within the company and has updated their proposal to match Spectrums one-time community donation, provided in two parts. They have also committed to a 33% increase in the current profit sharing provided to Pine Ridge. They disclosed the pricing Pine Ridge will enjoy for the full 5 year term of min 200/20 Mbps service offered to all high speed data subscribers. Special community pricing will be: 200/20 Mbps for \$60, 300/30 Mbps for \$70 or 500 Mbps for \$80. I have also been informed that Hargray is working on an APP that will allow cable users to view their cable service from Smartphones as well as Roku devices that have the Hargray APP downloaded. In addition, they are working on ala cart pricing as well as, smaller cable packages to meet the needs of those who use their cable services. Unfortunately, nothing can be done for the pricing as it is negotiated separately with each of the different network providers.
