ACC Report: Hector stated that there had been three ACC approvals since last meeting.

Community Improvement: Gabriel reported that signs have been added to the Community Board. The Board will be used by the Board and by residents to post their services. He would like to the community events posted on the Board and would like to see the events posted on the Association's website.
