Gabriel reported for the Parking Committee. Gabriel, Betty and owner Mr. Johnson will be looking at difference locations within Pine Ridge where additional parking spaces may be developed. Gabriel will be getting out the mailings regarding parking in the subdivision, a problem arose last month and they did not go out.

Betty reported for the Security Committee. It was pointed out that someone in the subdivision would need to step up to monitor and service the cameras in the park.

Lisa reported for the Social & Communication Committee. Due to the lack of assistance from residents there will not be a chili cookoff in November. The yard sale has been rescheduled for Saturday October 18th, 2025, since it was rained out on Saturday October 11th. Some of the food trucks which were to be at the October 11th yard sale will not be able to be at the October 18th yard sale. The Halloween party is still on from 5PM to 6PM.
