## **PINE RIDGE POA BOARD OF DIRECTORS MEETING MINUTES**

Painting of Speed Humps: Robert reported on the two proposals received to paint the speed humps and stop bars. A third company that was asked for a proposal did not reply and a fourth company declined to send a proposal. Gabe made a motion to contract with MAJ to paint the speed humps and stop bars. Betty seconded the motion, the motion passed.

New Business:

Power of Solar Cameras: Robert reported that he contacted Hilton Head Solar and they said they would be interested in discussion the possibility of installing a solar panel to power the solar cameras in the park.
